Thank you for the interest you have shown in sponsoring a trainer at Kira Farm Development Centre.

We have created a scheme whereby any money you donate on a regular basis will be used to directly fund a trainer's wage at Kira Farm Development Centre.

Kira Farm is a unique training project set in 22 acres of fertile farmland 14 miles north of Kampala. It is designed for parentless and vulnerable young people that have missed the opportunity to continue with secondary education. Each student joins the training programme for a 12 month syllabus and will be educated in relevant vocational skills (carpentry, hairdressing, tailoring and construction) and conservation farming skills, enabling them to return to their communities to support their families and pass on the knowledge they have gained.



Most of our trainers are part time and earn about £125 per month - you can decide what percentage of their salary you would like to contribute. If you wish, you can contact your trainer via Skype and email to encourage and support them in their work.

This innovative project is transforming many young Ugandan lives. Thank you for considering supporting one of our trainers.
